
The system is supplied for lowbudget applications, where the insulation of joints and fittings can be handled in the field by your own personnel.

Straight sections of pipe, in standard lengths and available in several materials, are factory-insulated and jacketed for delivery to the jobsite, ready for field insulation and jacketing of joints and fittings.

Pre-molded covers for tees, elbows, flanges and couplings with polyurethane foam and mixing aids are available as ordered.

Although pipe fittings are normally supplied by the contractor, custom fabricated fittings (tees, and 90° and 45° elbows) can be supplied by Ricwil for ECONO-GARD piping systems.

Sealing tape is provided for sealing connections between jacketing on adjacent components in aboveground and underground systems.

Avoid skin contact with materials in liquid state.




#### First Aid:
