Helmet Holder

Zico's helmet holder has been tested to 9 G's and complies with the 2009 edition of NFPA 1901 for use inside of crew cabs. It holds both traditional and contemporary style helmets without any adjustment needed. To secure the helmet, simply slip the helmet's hook onto the mount and pull the strap over the crown. Removing the helmet is as simple as pulling the strap down and lifting the helmet up.

The New NFPA 1901 - 2009 Standard Calls For:

- ✓ 1 - ANSI 207 Public Safety Vest for each seating position in apparatus (see below & back cover)
- ✓ 5 - Fluorescent Orange Traffic Cones 28" high with reflective striping (p. 265)
- ✓ 5 - Illuminated Warning Devices such as Flares or Illuminated Traffic Cones (p. 263-270)
- ✓ 1 - Automatic External Defibrillator (AED) (p. 181)
- ✓ No fire helmets may be worn by persons riding in enclosed driving and crew areas
- ✓ At least 50% of the rear-facing vertical surface of the fire apparatus must have reflective striping
