Each lifeline works independently, extending up to 6 feet and automatically retracting providing fall protection and mobility 100% of the time!

Reduced Fall Distances and Forces Talon's automatic, inertia activated brake will lock quickly stopping a falling worker within inches - providing more protection at low heights. With the lifeline secured overhead, the total fall distance

(free-fall + deceleration) is limited to 42 inches or less. By reducing fall distance, the arresting forces are also minimized helping keep the worker safe and sound.
