With an independently motorized ceiling closure.



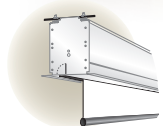
All the advantages of the Access, plus an independently motorized ceiling closure. The extruded aluminum case is plenum rated (UL approved for use in environmental air space). Case can be installed in advance of screen. See page 6.

- When closed, the motorized closure forms a solid bottom panel giving the ceiling a clean appearance.
- Touch a switch or wireless transmitter and the door of the Ultimate Access opens into the case before the viewing surface descends.
- Entire closure extends down as required for screen installation or adjustments.

**Ultimate Access/Series V**—Motorized screen with our Tab Tensioning System in choice of M1300, M2500 or HiDef Grey front projection surface, as well as Cineflex rear projection surface. Sizes through 12' wide.



**Ultimate Access/Series E**—Motorized screen with choice of viewing surface: Matt White, Glass Beaded, High Contrast Grey or acoustically transparent AT1200 or AT Grey. Sizes through 12' wide.



## System Options

- **Extra Drop**—Up to 12' overall height, either screen surface color or black.
- **Black Masking Borders**—Borders are optional for Series E in AV format, standard for all others.
- **Motor and Control Options**—This screen is available with optional Quiet Motors. See page 4 for more details. Controls may be built into case.
